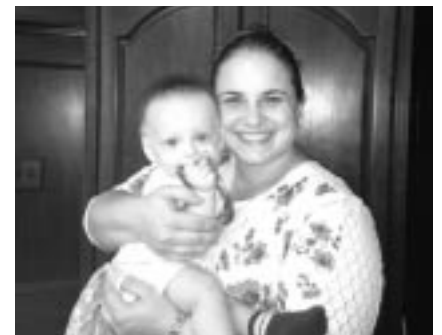
## PEB KIDS highlights

## Don't just celebrate, DESIGNATE

If you will be celebrating the holidays with alcoholic beverages, be sure to designate a nondrinking driver or call a cab. If you are hosting a party, stay sober, offer nonalcoholic drink options, and be sure that your guests are sober when they leave.



### Here are a few sobering holiday statistics:

- In 2012, in the month of December alone, 830 people lost their lives due to drunk driving.
- Between 2007 and 2011, alcohol-impaired drivers were involved in December wrecks that resulted in 4,169 total deaths.
- Every day, almost 30 people in the United States die in motor vehicle crashes that involve an alcohol-impaired driver.
- On average someone is killed by a drunk driver every 48 minutes.
- Of the 1,210 traffic deaths among children ages 0 to 14 years in 2010, 211 (17 percent) involved an alcohol-impaired driver.
- Research shows that alcohol-related crashes cost the public an estimated \$114.3 billion annually.
